

#1105 The Door of Heaven and the Gate of God – The Two Eliakims: The *second phase* of the curse of the *second* Eliakim (Jehoiakim) and the curse of Elijah (Malachi 4:6), part 17, The Coming of Elijah on April 9, 1906, through the “Elijah Company”

*Malachi 4:5-6 (KJV) Behold, **I WILL SEND YOU ELIJAH the prophet before the coming of the great and dreadful day of the LORD:***

*6 And he shall turn the heart of the fathers to the children, and the heart of the children to their fathers, **LEST I COME AND SMITE THE EARTH WITH A CURSE.***



The First Coming Elijah and Second Coming

Elijah. John the Baptist in substantial measure fulfilled the prophecy of Malachi 4:5-6, for he came in the spirit and power of Elijah (Luke 1:16-17). Jesus Christ also referred to John the Baptist as Elijah (Matthew 11:14), again, meaning that John the Baptist came as a second Elijah in the spirit and power of Elijah. Near the Second Coming of Jesus Christ, there is another who comes as a second Elijah, meaning, in the spirit and power of Elijah.

The Elijah Company. There is a doctrine that is particularly associated with the Charismatic

movement, which would trace its roots back to Azusa Street and April 9, 1906. It is called the “Elijah Company.”

Key Understanding #1: *The Elijah Company.* A “corporate Elijah,” that is, a group of prophets, or even a very large number in the Body of Christ, is to come in the last days, anointed with the “Elijah spirit,” in fulfillment of Malachi 4:5-6, rather than the prophecy of the passage being fulfilled through Elijah, or a single man coming in the spirit and power of Elijah. The group with the Elijah spirit is often called the *Elijah Company*.

It takes time to go through the material, but here are samples of websites that refer to the doctrine of *Elijah Company*. It is not necessarily recommended that the time be taken to go through all the material. It is provided primarily for the purpose of clarifying the strong existence of the acceptance and practice of the doctrine of *Elijah Company*.

Key Understanding #2: *The “kingdom now” Elijah Company.* The vast majority of those promoting the spirit and doctrine of *Elijah Company* represent “Kingdom Now” and “One Nation Under God” doctrines that are prophetically associated with the *counterfeit* Two Olive Trees/Two Witnesses of *Joel’s Latter Rain* of April 9, 1906, and *Joel’s Latter Rain* of April 6, 1917. **What the Elijah Company actually ends up representing is not the spirit and power of Elijah, but the prophets of Baal whom Elijah was against.**

*1 Corinthians 4:8 (NIV) Already you have all you want! Already you have become rich! **YOU HAVE BECOME KINGS—AND THAT WITHOUT US!** How I wish that you really had become kings so that we might be kings with you!*
