

**#1725 The Yom Kippur War and the Abomination of Desolation – The pre-World War II U.S. waxing great toward the South and toward the East as a *second Syria/Antiochus IV Epiphanes*, part 18, *Toward the South: The Monroe Doctrine, (ii), America’s Monroe Doctrine of Democracy vs. the Holy Alliance of Prussia, Austria, and Russia presaged Woodrow Wilson’s America becoming the Democratic Fourth Christian Rome at the time of the demise of the Autocratic Prussian, Austrian, and Russian Christian Roman Empires***

Unsealing #169 was titled The World War I *Second* Ascension of America – A Double Fourth: Death of the Three Christian Roman Empires, and Ascension of the *Fourth Christian* Roman Empire, the United States of America.

**Review** (of the Key Understanding of Unsealing #169): *Wilson vs. the Holy Alliance*. The three former Holy Alliance Christian Empires – Prussian Germany, Austria, and Russia – each supposedly representing the true faith of Jesus Christ, passed away due to the events of World War I. The United States, which was already inheriting the position as the *Fourth Rome* because of the passing away of *one* of those empires – the Romanov Russian Empire – was now also fully and additionally inheriting the demonically anointed *Christian Empire* mantle of the other *two*, only this time *in the name of Democracy, not the Autocracy* of Prussia, Austria, and Russia. Thus, the United States was becoming a *Fourth Christian Roman Empire of its day*, becoming the sole falsely anointed replacement for the *Three Christian Roman Empires* (the former Holy Alliance members) of Germany, Austria, and Russia.



**Monroe vs. the Holy Alliance.** One of the major purposes of U.S. President James Monroe’s Monroe Doctrine was to counter any decision made by the Holy Alliance of Prussia (Germany), Austria, and Russia to aid Spain in regaining territories that had declared their independence in Latin America. In doing so, the motive of the Holy Alliance would have been to curb revolutions against autocratic rule in Europe.

**Key Understanding #1: Monroe vs. Prussia, Austria, and Russia; Wilson vs. Prussia, Austria, and Russia.** U.S. President James Monroe represented the *first* ascension of the United States through the Revolutionary War, while U.S. President Woodrow Wilson represented the *second* ascension of the United States during World War I. Each president had to deal with the nations/empires of Prussia, Austria, and Russia.



**Key Understanding #2: James Monroe making the Western Hemisphere safe for democracy, and Woodrow Wilson making the whole world safe for democracy.** The ‘New World vs. Old World’ situation created by the Monroe Doctrine, which supported the independence of New World colonies from the European colonial powers, and which thus was in basic opposition to possible motives of

the Holy Alliance of Prussia, Austria, and Russia to aid Spain in regaining Latin American colonies that had declared independence in the New World, *presaged* the geopolitical (and prophetic) situation during World War I when the United States, representing *Christian Democracy*, became the Fourth Christian Rome, at the time of the demise of the Prussian, Austrian, and Russian Empires, which had represented *Christian Autocracy*.



[Interestingly and ironically, in the Monroe Doctrine, the United States pledged that if the European powers would stay out of North and South American affairs, the United States in turn would stay out of European conflicts and affairs.

Obviously, the demise of the former Holy Alliance empires of Prussia and Austria in World War I was directly tied to America entering the European conflict.]

***Daniel 8:9 (KJV) And OUT OF ONE OF THEM*** [the *second* Syria, the United States, located in the northwest part of the world] ***CAME FORTH A LITTLE HORN, which waxed EXCEEDING GREAT, toward THE SOUTH*** [for American independence (from which came the Northwest Territory with its slave-prohibiting Northwest Ordinance) triggered the independence of Spanish colonies from Spain *toward the south*], ***and toward THE EAST, and toward THE PLEASANT LAND.***
