

**#2100 The Yom Kippur War and the Abomination of Desolation – The post-World War II U.S. waxing great toward the South and toward the East as a *second* Syria/Antiochus IV Epiphanes, part 359, Nuremberg Day of Judgment, (Ixii), The Hel Spit: Wilson’s Fourteen Points and the creation of a “united, independent, and autonomous Poland with free, unrestricted access to the sea”**

**President Woodrow Wilson’s role in resurrecting Poland.** At a meeting with Polish leader Ignacy Jan Paderewski (who would become the third Prime Minister of Poland) in November 1916, President Woodrow Wilson recorded his first known expression of sympathy for the idea of an independent Poland. On January 21, 1917, in an address to the U.S. Senate, Wilson made mention of a “united Poland” and its right of “access to the sea.” One year later, on January 8, 1918, the thirteenth of Wilson’s *Fourteen Points*, which were a basis for ending the war and securing the peace for a free world, was a “united, independent, and autonomous Poland with free, unrestricted access to the sea.” The policies of other Western Powers altered back and forth for various political reasons, but an overall policy developed for the revival of Poland. Since Poland was to have unrestricted access to the sea, the issue of what would be called the Polish Corridor and the status of Danzig would become central to the Versailles peace settlement. In 1919, the state of Poland was revived by action of the Allied powers at Paris, and the undertaking to give the new country an independent access to the sea was honored by giving Poland the so-called “Corridor”. Although Danzig lay within the Polish Corridor, because of its large German population, the Allies gave it, together with a surrounding area of 730 square miles, the status of a “free city.” It was under the protection of the League of Nations.



**Key Understanding** (which is the same as is in Unsealings [#2094–#2099](#)): *The dispute over the Polish Corridor, which included Hel Spit. The Polish Corridor refers to a corridor of land that allowed Poland to be linked to the Baltic Sea, which encompassed land that belonged to Germany in World War I, and, furthermore, which now split in two what was part of Germany during World War I. Adolf Hitler’s premise for beginning World War II significantly surrounded the dispute over the city of Danzig (Gdansk, Poland today) and the Polish Corridor, which included Hel Spit. The spiritual/prophetic and even historical point is that the Lord ordained the land (the Polish Corridor) that included the Hel Spit to be directly linked to Hitler’s excuse for the invasion and occupation of Poland – which led to the death of millions of Jews – for the purpose of illustrating that the Lord was not going to be mocked concerning the mocking of, spitting upon, striking of, and crucifixion of his Son, Jesus Christ.*
