

**#2105** The Yom Kippur War and the Abomination of Desolation – The post-World War II U.S. waxing great toward the South and toward the East as a *second* Syria/Antiochus IV Epiphanes, part 364, **Nuremberg Day of Judgment, (lxvii), The Hel Spit: The Soviet Invasion of Poland**

**The Fourth Partition of Poland.** In the August 23, 1939, Nazi-Soviet Pact, Germany and the USSR agreed to divide Poland. See the map *below right*. This World War II division of Poland is sometimes referred to as the Fourth Partition of Poland, with the three partitions of 1772, 1793, and 1795 serving as the predecessors.

**The Soviet invasion of Poland.** Germany invaded Poland from the west on September 1, 1939, an act that served as the start of World War II. On September 17, 1939, the Soviet Army invaded Poland from the east. The Soviet government announced that it was acting to protect the Ukrainians and Belarusians who lived in the eastern part of Poland, because the Polish state had collapsed in the face of the German attack and could no longer guarantee the security of its own citizens. The Red Army quickly achieved its targets, vastly outnumbering Polish resistance. About 230,000 or more Polish soldiers were taken prisoners of war.

The Soviet government annexed the territory newly under its control and in November declared that the 13.5 million Polish citizens who lived there were now Soviet citizens.

Later, Nazi Germany would begin its invasion of the Soviet Union on June 22, 1941, pushing the Soviets entirely out of Poland.

**Key Understanding** (which is the same as is in Unsealings [#2094](#)–[#2102](#), [#2104](#)): *The dispute over the Polish Corridor, which included Hel Spit. The Polish Corridor refers to a corridor of land that allowed Poland to be linked to the Baltic Sea, which encompassed land that belonged to Germany in World War I, and, furthermore, which now split in two what was part of Germany during World War I. Adolf Hitler’s premise for beginning World War II significantly surrounded the dispute over the city of Danzig (Gdansk, Poland today) and the Polish Corridor, which included Hel Spit. The spiritual/prophetic and even historical point is that the Lord ordained the land (the Polish Corridor) that included the Hel Spit to be directly linked to Hitler’s excuse for the invasion and occupation of Poland – which led to the death of millions of Jews – for the purpose of illustrating that the Lord was not going*

**to be mocked concerning the mocking of, spitting upon, striking of, and crucifixion of his Son, Jesus Christ.**

*Mark 14:63-65 (KJV) Then the high priest [Caiaphas] rent his clothes, and saith, What need we any further witnesses?*

*64 Ye have heard the blasphemy: what think ye? And they all condemned him to be guilty of death.*
