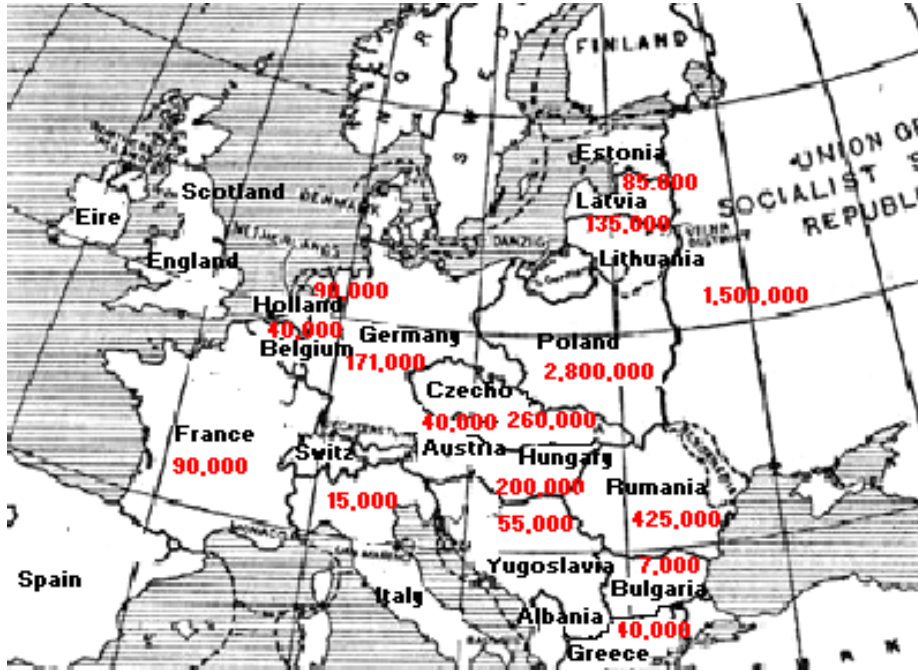


#2106 The Yom Kippur War and the Abomination of Desolation – The post-World War II U.S. waxing great toward the South and toward the East as a *second* Syria/Antiochus IV Epiphanes, part 365, Nuremberg Day of Judgment, (Ixviii), The Hel Spit: The war that ostensibly began because of the dispute over the Polish Corridor, which included Hel Spit, led to the deaths of 2.8 million Jews in Poland



Over 90% of Polish Jewry, about three (3) million, were killed during the Holocaust (also called Shoah in Hebrew) in Nazi-occupied Poland, along with approximately three million non-Jewish Poles. The Nazi occupation of Poland resulted in the death of one-fifth of the Polish population. There was no collaborationist government in Poland, and relatively little collaboration by individual Poles with the Nazis in Poland, including the Holocaust.

The numbers presented on the map above are graphically represented in the chart which follows:

Key Understanding (which is the same as is in Unsealings [#2094–#2102](#), [#2104–#2105](#)): *The dispute over the Polish Corridor, which included Hel Spit. The Polish Corridor refers to a corridor of land that allowed Poland to be linked to the Baltic Sea, which encompassed land that belonged to Germany in World War I, and, furthermore, which now split in two what was part of Germany during World War I. Adolf Hitler’s premise for beginning World War II significantly surrounded the dispute over the city of Danzig (Gdansk, Poland today) and the Polish Corridor, which included Hel Spit. The spiritual/prophetic and even historical point is that the Lord ordained the land (the Polish Corridor) that included the Hel Spit to be directly linked to Hitler’s excuse for the invasion and occupation of Poland – which led to the death of millions of Jews – for the purpose of illustrating that the Lord was not going to be mocked concerning the mocking of, spitting upon, striking of, and crucifixion of his Son, Jesus Christ.*
